

Terms and conditions – Night Watch competition

This page sets out the terms and conditions applicable to the Night Watch competition (the “competition”). This is a legal document (including the [AkzoNobel Privacy Policy](#)) which is the agreement between you (whom we refer to as “you”, “your” or “participant”) and us. We are Akzo Nobel Nederland BV, and we are the promoter of the competition. We are a company registered in the Netherlands with our registered office at Christian Neefestraat 2, 1077 WW Amsterdam (and we refer to ourselves as “AkzoNobel” “we”, “us” or “our” in this document).

1. Entry to the Night Watch competition

- 1.1 The Night Watch competition is a quiz asking users facts related to Rembrandt’s Night Watch painting. Ten multiple choice questions will be published via AkzoNobel’s Instagram account for a period of three days. The first day (August 3 at 18:00 CET) three questions will be published, the second day (August 4 at 18:00 CET) three questions will be published and on the third day (August 5 at 18:00 CET) four final questions will be published.
- 1.2 To enter our competition, you simply need to enter your answers in the comment section of the last post of questions out of three that we publish (the post published on August 5 at 18:00 CET). By submitting your entry, you accept these rules.
- 1.3 The competition will be open to participants beginning August 3, 2020, at 18.00 CET.
- 1.4 The competition will remain open until August 9, 2020, at 23:59 CET. Any entries received after the closing of the competition will be ineligible for consideration.

2. Eligibility

- 2.1. Only one entry per person can be submitted. No third party entries will be permitted.
- 2.2 Employees of the AkzoNobel Group, advertising and promotion agencies, and the immediate families of each, may enter.
- 2.3. AkzoNobel accepts no responsibility for entries that fail to be received or delivered. Proof of submission is not proof of entry.

2.4. AkzoNobel reserves the right to verify the eligibility of participants and may deny anybody entry at its sole discretion. AkzoNobel does not accept liability for any ineligible entries.

3. **The prize**

3.1. There will be one winner of the competition. The prize consists of a mug, a pair of socks and an umbrella.

3.2. The prize is non-transferrable.

3.3. The prize is as stated and you are not entitled to obtain another product or cash alternative from us.

3.4. Should AkzoNobel be unable to provide the prize as listed it reserves the right to provide a substitute prize of similar value.

4. **Selecting the winner**

4.1. After the ten multiple choice questions are published, participants can enter their answers in the comment section of the last post of questions out of three that we publish. Participants will have four days to enter their answers (August 5 18:00 CET – August 9 23:59 CET). Once the competition is closed, the winner will be selected. AkzoNobel employees will review all the comments and identify the first person who added a comment with all ten correct answers. This participant will be selected as the winner of the competition.

4.2 AkzoNobel will notify the winner on August 12 at 18:00 CET via AkzoNobel's Instagram page by tagging the winner's Instagram account in our announcement post and notifying the winner privately through a private message on their Instagram page.

5. **Claiming your prize**

5.1. If AkzoNobel does not receive a response from the winner of the prize within three working days of being notified, AkzoNobel reserves the right, within its sole discretion, to deem the prize as unaccepted and to offer the prize to an additional participant.

5.2. The prize will be delivered by post to the location where the winner lives. AkzoNobel will pay the cost of shipping and delivery.

5.3. If a prize is not accepted by the winner in accordance with the terms above, AkzoNobel may, within one day, select an additional winner via the same process used to select the initial winner. AkzoNobel employees will review the comments and identify the second person who

posted all the correct answers or next highest number of correct answers. Such subsequent winner will be notified as per clause 4.2, save that such notification will be after one working day.

6. **Privacy**

6.1. Personal data provided to AkzoNobel for the purpose of entering this competition will be processed in accordance with the [AkzoNobel Privacy Policy](#) or as otherwise set out in these terms and conditions. We will only use personal data submitted for the purposes of selecting, announcing and contacting winners.

7. **Other restrictions**

7.1. AkzoNobel shall be entitled to terminate or modify the competition or to modify these terms and conditions at any time prior to the closing date of the competition by publishing any such modification or termination on any AkzoNobel website, Instagram account or Facebook page.

7.2. Failure to comply with any aspect of these terms and conditions will result in the invalidation of your entry. In the event of a dispute, the decision of AkzoNobel shall be final and binding, and no correspondence will be entered into.

7.3. AkzoNobel reserves the right to promote this competition on www.akzonobel.com, Instagram and Facebook, subject to the terms and conditions governing the use of the aforementioned websites.

7.4. AkzoNobel shall be under no obligation to run the competition or award prizes in the event it is unable to do so due to circumstances or causes beyond its reasonable control. You agree that by entering this competition no obligation on the part of AkzoNobel shall be attached for such events described in the preceding sentence.
